Why?	Financial companies choose how they share your personal information. Federal law gives consumers the right to limit some but not all sharing. Federal law also requires us to tell you how we collect, share, and protect your personal information. Please read this notice carefully to understand what we do.

<b>Who is providing this notice?</b>	Elmcore Securities LLC, its parent company, Elmcore Group Inc., and any divisions, subsidiaries, companies, and affiliated entities of Elmcore Securities LLC or Elmcore Group Inc., collectively "Elmcore".
What We Do	
<b>How does Elmcore Securities LLC protect my personal information?</b>	To protect your personal information from unauthorized access and use, we use security measures that comply with Federal law. These measures include computer safeguards and secured files and buildings.  For more information, please refer to the Elmcore Securities LLC Disclosure Statements.
<b>How does Elmcore Securities LLC collect my personal information?</b>	We collect your personal information, for example, when you: <ul style="list-style-type: none"> <li>▪ Open an account</li> <li>▪ Tell us about your investment portfolio</li> <li>▪ Give us your contact information</li> <li>▪ Show us your government issued ID</li> <li>▪ Direct us to sell your securities</li> <li>▪ Pay us by check</li> <li>▪ Seek financial or tax advise</li> <li>▪ Seek advice about your investments</li> </ul> <p><b>We also collect your personal information from others, such as credit bureaus, affiliates, or other companies.</b></p>
<b>Why can't I limit all sharing?</b>	Federal law gives you the right to limit only: <ul style="list-style-type: none"> <li>▪ Sharing for affiliates' everyday business purposes—information about your creditworthiness</li> <li>▪ Affiliates from using your information to market to you</li> <li>▪ Sharing for nonaffiliates to market to you</li> </ul> <p>State laws and individual companies may give you additional rights to limit sharing. See below for more on your rights under state law.</p>
<b>What happens when I limit sharing for an account I hold jointly with someone else?</b>	Your choices will apply to everyone on your account – unless you tell us otherwise.
Definitions	
<b>Affiliates</b>	Companies related by common ownership or control. They can be financial or nonfinancial companies. <ul style="list-style-type: none"> <li>▪ <b><i>Our affiliates include companies under common control or ownership of Elmcore and its management and shareholders.</i></b></li> </ul>
<b>Nonaffiliates</b>	Companies not related by common ownership or control. They can be financial and nonfinancial companies. <ul style="list-style-type: none"> <li>▪ <b><i>Elmcore Securities LLC does not share with nonaffiliates so they can market to you.</i></b></li> </ul>
<b>Joint Marketing</b>	A formal agreement between nonaffiliated financial companies that together market financial products or services to you. <ul style="list-style-type: none"> <li>▪ <b><i>Elmcore Securities LLC doesn't jointly market.</i></b></li> </ul>
